PUBLIC QUESTIONS	<p>Tony Millar attended re planning application (SMD/2020/0399) for 12 x Shepherd Huts where the Parish Council Objected following last meeting. He gave further details on the application:-</p> <ol style="list-style-type: none"> 1. Oversaturation – area where proposing for the huts in region of 5000sqm each hut will have over 400sqm around it (equivalent to 1 ½ tennis court) so not tightly space in there. 2. Highways – only issue was parking which had been resolved with Planning Officer. No issue raised re Tickhill Lane being single track. 3. Volume of traffic - concerns by residents – he had not received any complaints on this, no reference in PC minutes for over 3 years. 4. Noise and light pollution would not be an issue. 5. Wants a “Centre Parks” feel to the site. 6. Covid-19 situation, government are vocal in supporting innovations and enterprise. They have received some funding from the COVID Recovery Innovation Fund. 7. Regarding the Local Plan – worked hard to support this. This will complement the area with no detrimental or further effects It will increase income in the local economy. <p>Cllr Bateman thanked him for attending and he had made his points eloquently. This will be discussed later in the meeting.</p>
